- Updated economic value of international students
- Code of Practice for Education Agents

Challenges with work placements post Brexit was raised as a concern by Lord Willetts.

It was agreed that letters to Ministers would be written in support of:

• Ongoing visa concessions

• Student accommodation being used as quarantine for international students

It was agreed that events would be held before the summer break on the challenges:

- in the English language sector
- with post-Brexit work placements

Further consideration would be given to an event after summer taking stock of progress with the recommendations in the APPG's 2018 Report 'A sustainable future for international students in the UK'.

The Chair Paul Blomfield MP closed the meeting at 12:20pm.

The AGM was followed by a meeting with Graham Stuart MP, Minister of State for Exports and further discussion on progress in implementing the UK's International Education Strategy.
